MINUTES OF THE MEETING

The Chairmen, BOS of Faculty of Management Studies welcomed the members and introduced the internal members and thanked each of them for sparing their valuable time to attend the meeting. Our Academic Dean Dr.R.P. Anto Kumar gave the introductory speech.

The chairmen presented the newly framed 2022 draft curriculum & syllabi for Semesters 1 to 4 and explained about the theory courses, mandatory courses, elective courses and practical courses opted for the Semester 1 to 4. Syllabi for I year were discussed in detail.

The BOS members gave the following suggestions

Department of Management Studies P.G.

- Panel member discussed to change the Title of subject Business Tools laboratory as Business Analytics Lab or Business Tool Lab I for I semester and Business Tool Lab II for II semester. Basic concepts of Business Analysis can be added to the syllabus and Cloud based system or computerized accounting management can be added to the Syllabus.
- In First Semester the subject Legal Aspects of Business, experts suggested to add Company Registration procedures for start-ups.
- II semester laboratory syllabus can be changed as Big data Analytics instead of Data Analysis. The changes in Big Data Analytics can be specified in the syllabus.
- The subject title of Production management can be changed to Operations Management or Production and Operations Management.

Changes suggested by panel members in syllabus were:

- Services operations topic can be added in unit 4 or unit 5. Lean management topic can be removed from unit 5, because the topic is not related to quality management. 5's concepts and SA(Social Accountability)8000 can be added in unit 5.
- Lean manufacturing or agile manufacturing can be added in unit 4. Supply chain management topic can be added in unit 2 and in unit 4 Inventory planning and control topic can be changed to Inventory techniques.
- In II semester experts suggested to take the students for outbound training to develop
 the team building skills in the employability enhancement course Leadership skill
 development.
- In second semester, Unit 5 can be shortened instead of heavy content in Strategic Management subject.
- For summer training experts suggested to change as organizational study since the students are studying about the functional departments of the organization.
- Industry expert suggested motivating the students for evening job (Earn While You Learn) to develop the managerial skills and it should be added as extra credit.
- For open electives, experts suggested to choose Entrepreneurship Development.
- Panel members suggested to specify the credit instead of credit range and also to specify the calculations for CGPA in Regulation.
- In III semester marketing elective the title Retail marketing can be changed into Retail Management and Marketing, also Service Marketing can be changed into Services Management and Marketing.
- In Second semester Unit 5 topic of Human Resource Management can be to Performance Planning and Control instead of Performance Evaluation and control.
